Reports

- Washington State Parks by Jeff
 The beetles are killing approximately 100 trees per park, now 2 times a
 year. Thus the reason for closing Federation Forest this week. They drop
 the timber in the forest to leave nutrients. Tribes want whole logs.
- New gateway sign by Steven, Troy, and Thomas Steven shared the Welcome to Enumclaw rendering. There was discussion of native plants to be placed around the sign to comply with landscape policies by Enumclaw.

Steven submitted a 60 page document for a permit to erect the sign. Board discussed that the city requested a "Welcome to Enumclaw" feature on the back of the sign. Sample attached. There is a good possibility the City of Enumclaw will contribute up to \$10,000 for the backside use of the sign. Unanimously approved.

• WSDOT, MRNP, and USFS

Discussion on keeping the byway open year around from Enumclaw to Cayuse Pass Hwy 123. There are interagency agreements between DOT, FS Park and reimbursement issues of \$60-70,000.

Hwy 410 Foothills connector discussion regarding affect on fish and the Muckleshoot Tribe interests on the White River.
