

# Chinook Scenic Byway Board Meeting

December 7<sup>th</sup>, 2016

### **Potential location for Signage in Enumclaw**

Darryl Dickson offered to put up a west-side gateway sign visible to east-bound travelers and a Welcome to Enumclaw sign visible to west-bound travelers within Enumclaw city limits on his property at the intersection of 410 and 284th. He is the owner of both sides of the highway directly east of that intersection, and the signs are intended to be on the north side of the road. Various issues to be considered were discussed extensively, including: right of way from City of Enumclaw, right of way from WSDOT, ownership of the sign, placement in perpetuity, who would construct, permitting processes, etc. He's willing to consider, and discuss with his ownership group, an information kiosk nearby as well.

Darryl was hopeful of getting in-kind contributions from the community. Darryl has lots of experience raising funds in his community and is confident he can raise enough funds to build the sign. He's considering local Eagle Scouts to help the contractor with the construction work. For example: helping frame the structure, help with the fund raising, and in other aspects. They would work under professional supervision throughout the project.

Any funds raised would be donated to CSB, who would be paying the contractor. The sign would be owned by CSB, at the request of the owners. They will erect it in a location that works for everyone, but if someday someone bought that land and wanted to do something else with it, then he would have to let them. They can't guarantee perpetual placement there, if the land should change ownership in the future. The sign would be built with that in mind, so structural support would be needed underneath for purposes of lifting it up.

They need to see the schematics for the White Pass Scenic Byway signs – and then will make an application for a design review with the city to see what issues may arise. Moved by Danielle to move forward to exploring further, seconded by Steve Cadematori. Passed unanimously. Trip will contact Curt to get the schematic drawings of the WPSB sign. Then Darryl Dickson's owners group will submit it to the city of Enumclaw for a design review.

### **Corridor Management Plan Copies**

One copy given to Darryl Dickson, he paid \$10.00. Thomas Noyes took several copies for RTPO and other WSDOT program heads, regional heads, and headquarters.

#### **Pam Roach Resolution**

Pam sent draft language for the resolution to Trip, but Trip wanted to revise it, so it hasn't moved forward further. Trip will revise language and try to see if can be processed through the legislature.

#### **Approval of Minutes**

The following minutes were sent to the members via email: June 17, 2015, September 15, 2015, March 2, 2016, and September 21, 2016. Trip moved that they all be approved and Steven Cadematori seconded the motion. The motion passed unanimously with one correction: Tom Washington – in the 9/21/16 minutes – should have been Thomas Noyes. Danielle will upload the minutes to the website.

## **Quorums**

Currently, our quorum is a majority of the 11 Board Members, six persons. We also have two board positions that are vacant. So, we must have 6 persons to achieve a quorum. Trip proposed reducing the board numbers, by taking inactive board members off the list. These are the representatives from the Town of Naches and City of Enumclaw. This would bring our quorum requirement down to five persons. We further discussed a need for clarification of quorum requirements: A vacant position is interpreted as not being counted in quorum requirements, because they are not a voting member.

Our challenge is that it's difficult to achieve a quorum due to the consistent lack of participation from these two member entities, and therefore difficult to operate the business and facilitate quorum requirements. Trip will try to get a hold of Paul Williams at the Town of Naches, as it was discovered that his name wasn't actually on the meeting notification list. Trip will also contact the City of Enumclaw to see about their future participation.

At Milepost 46 - sign that says Crystal Mountain / Junction 123 / etc. Maybe a CSB logo can be incorporated into this sign.

The proposal was for the Chinook Scenic Byways signage and did not include a proposal for any other signage on the gateway signage at this time.
