## Status and Update - Curt Warber - Corridor Management Plan

Comments on the Corridor Management Plan have been trickling in – from both the request for comments sheets and document markups.

- 1. Good news from Federation Forest they have some new staffing and can re-open for visitor hours and they are moving forward with visitor center and interpretive displays work. Some of the more extensive improvements considered for the park are not likely to happen in the foreseeable future. Expansions in staffing and hours also don't look feasible in near future.
- 2. Muckleshoot Tribe is likely to play a key role in Enumclaw to Mather section of the Byway in visual quality, forest quality, and recreational access. But, they're still figuring out their management direction on the forest. Curt is pulling out of the CMP anything related to their involvement in potential projects and land use so that we can let these relationships and programs evolve.
- 3. There is good support and high energy for CMP signage projects 1) Gateway Signs to identify the byway; 2) Mather Memorial Parkway gateways revisions to add CSB recognition and update
