#### **CSB 410 SIGNAGE REVIEW:**

The board reviewed the proposed sign to the byway, which will be placed on the north side Hwy 410 across from The Claw, with property owner Darrel Dickson. A design plan with city council, Mayor of Enumclaw City will include working with Enumclaw's Building department/engineer.

The engineer will need to sign off on the sign as it must be seismically constructed and withstand gusts of 120 mph.

So far, \$17,000 has been paid out to Parametrix.

Approximately 75-100 yards of ravel needs to be secured for construction (Perhaps Scott Corliss and/or Bart Jensen would contribute?

Steven will contact the Tourism Board, Troy Couch will contact Chris Passenett regarding having the sign designated as a temporary structure. IF TEMPORARY, THE SIGN COULD CONVERT TO THE CITY OF ENUMCLAW.

Is it possible the sign could piggy back on Mather Memorial Parkway signs and Forest Service which need replaced as well?

Can the logo be added to the Naches and Mt Rainier, and Chinook Pass signs?

Chip Jenkins is the newest Park Superintendent, Tiana and Frank Deberry are running Alterra which was formerly Crystal Mountain Resort.

ICON passes and passholder should be alerted to the byway.

Sign subcommittee (Trip, Darrel and Steven) have an agreement wit PCMI, easement on Darrel's land with a 20yr renewable.

## FRIENDS OF THE CHINOOK SCENIC BYWAY

The account currently has \$492

The board would like to raise \$13-\$25,000 for the new sign and for operation of the CSB board (website, ads, flyers, kiosk etc.)
